The City currently bills the first of the odd-numbered months for the preceding two months. The charge for water consists of a "to the tap" charge, and a usage charge. As of 01/01/2006 the "to the tap" charge for a single family residence is \$20.70 per month. The gallons used charge is \$.0028 per gallon used. As of 12/1/07 the stormwater management fee is \$5.00 per month.
